Pracinostat is being developed in combination with azacitidine for the treatment of patients with newly diagnosed AML who are ≥ 75 years of age or unfit for intensive chemotherapy and high-risk MDS. The Company's clinical development pipeline also includes ME-401, an oral PI3K delta inhibitor currently in a Phase Ib study in patients with recurrent chronic lymphocytic leukemia or follicular non-Hodgkin's lymphoma, and ME-344, a mitochondrial inhibitor currently in an investigator-sponsored study in combination with bevacizumab for the treatment of HER2-negative breast cancer.
